### **ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 8th January, 2025

**No. 14(9)/18/2021-HE (Absp):** Whereas, consequent upon the taking over of 6 Aided Colleges namely, (1) Biramangol College, Sawombung, (2) Kakching Khunou College, Kakching Khunou, (3) Liberal College, Luwangsangbam, (4) Mayai Lambi College, Yumnam Huidrom, (5) Standard College, Kongba & (6) Thambal Marik College, Oinam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018, the Administrative Department had appointed 478 (four hundred and seventy eight) numbers of teaching staff and 163 (one hundred and sixty three) numbers of non-teaching staff and 7 (seven) numbers of teaching staff and 1 (one) non-teaching staff of the erstwhile 6 (six) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, No. 31/3/AIDED-COL/CONVSN/ HE-16 (GIA) (Pt.) dated 13.12.2019 and No. 31/3/AIDED-COL/CONVSN/HE-16(Age Bar) dated 26.05.2020 with due concurrence of Finance Department (PIC);

- 2. And whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-17/3/2022-DUHE-DU & HE dated 22<sup>nd</sup> September, 2023 has furnished a report of the Verification Committee on the reexamination of the discrepancies in assignment of effective dates of joining/final absorption in respect of 29 (twenty nine) teaching staff of Kakching Khunou College, Thambal Marik College, and Mayai Lambi College who were initially appointed as teaching staff under the category Qualified at the time of initial appointment /Qualified at the time of taking over/ Unqualifed-Approved /Unqualifed-Unapproved group vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 31/3/AIDED-COL/CONVSN/HE-16 (GIA) (Pt.) dated 13.12.2019;
- 3. And whereas, out of the aforementioned 29 (twenty nine) teaching staff at para 2 above, 11 (eleven) teaching staff as listed in the table below at para 5 have been appointed vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 & No. 31/3/AIDED-COL/CONVSN/HE-16 (GIA) (Pt.) dated 13.12.2019 with due concurrence of Finance Department (PIC) under the category "Qualified at the time of initial appointment /Qualified at the time of taking over/ Unqualified-Approved /Unqualified-Unapproved group" without categorization of unqualified phase as Lecturer & qualified phase as Assistant Professor;
- 4. And whereas, after examination of the proposal for rectification of the service records in respect of these 11 (eleven) teachings staff mentioned in the para above, the matter was referred to Finance Department (PIC) for concurrence to the proposal of the Verification Committee and FD (PIC) has concurred/agreed to the rectification in the initial date of joining as effective date of unqualified and qualified in the appointment/ absorption order in respect of the above mentioned 11 (eleven) teaching staff of 3 (Three) Colleges in the manner shown in the table below at para 5;

5. Now, therefore, in partial modification of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, No. UHE-18010/1/2021-HTE-DHTE dated 18.08.2021, No. 14(9)/8/2019-HE(B)(CONVSN) dated 30.12.2020, No. 31/3/AIDED-COL/CONVSN/HE-16 (GIA)(Pt.) dated 13.12.2019, No. 7(2)/16/2018-HE(Pt.-I) dated 22.08.2020, No. 31/3/AIDED-COL/CONVSN/HE-16(Age Bar) dated 26.05.2020 and 31/3/AIDED-COL/CONVSN/HE-16(GIA)(Pt.) dated 27.07.2022 the Governor of Manipur is pleased to order the rectification as concurred by the Finance Department (PIC) in respect of the 11 (eleven) teaching staff as detailed in the Table below:
