## ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 10th January, 2025

No.15/24/82-W(Pt): Whereas, Shri Sagolsem Dhanamani Singh was recommended by a DPC meeting held on 22.6.1999 which was chaired by the Chief Engineer-I, PWD, Manipur for appointment to the post of Section Officer-I (Civil) on regular basis against the Meritorious Sportspersons quota. He was appointed on 08.03.2000 with the approval of the Government after completion of the then Election process.

- 2. Whereas, he had been posted and joined service as SO-I(Civil) at Building Division No.-I of PWD, Manipur. However, after serving his service for 22 days, a letter dtd. 31.3.2000 of the then Superintending Engineer (HQ), PWD, Manipur had disallowed him to continue his service with a condition to issue necessary appointment order when the ban on appointment is lifted/vacated by the Government which was imposed on 06.11.1999.
- 3. Whereas, at that point of time, no proper cancellation order of the appointment order dtd. 08.03.2000 was issued except issuing the letter dtd. 31.3.2000 of the then SE(HQ), PWD, Manipur wherein his service was disallowed to continue.
- 4. Whereas, being aggrieved, Shri Sagolsem Dhanamani Singh filed WP(C) No. 545 of 2001 and Review Petition No. 8 of 2010. However, no relief was granted after a prolonged contest of case till 2014. Thereafter, he had again submitted a Representation dtd. 14.8.2014 with a request to re-instate his service.
- 5. Whereas, the matter was placed before the Cabinet and the State Cabinet, in its meetings held on 30.4.2016 and 26.8.2016, allowed to his appointment as SO-I(Civil) in PWD, Manipur against the Meritorious Sportspersons quota in relaxation of the guidelines on appointment of meritorious persons as one time measure and exemption from consultation of MPSC vide appointment order No. 3/1/2016-CE dtd. 27.9.2016. Hence, he now serves as SO-I(Civil) at NH-III, PWD, Manipur.
- 6. Whereas, Shri Sagolsem Dhanamani Singh submitted a representation for counting of service from the first appointment vide order dated 08-03-2000 for consideration of (i) Old Pension Scheme (ii) to determine seniority from the date of first appointment i.e 08-03-2000 (iii) to fix pay notionally w.e.f 08-03-2000 without claiming arrear pay and allowances.
- 7. Whereas, the matter was placed before the Cabinet and the State Cabinet, in its meetings held on 10.10.2024, allowed for counting of service from the first appointment vide order dated 08-03-2000 in respect of Shri Sagolsem Dhanamani Singh, SO-I only for consideration of enrolment under Old Pension Scheme.

- 8. Whereas, Finance Department(PIC) and Department of Personnel has concurred to the Cabinet Decision dated 10.10.2024, for counting of service from the first appointment vide order dated 08-03-2000 in respect of Shri Sagolsem Dhanamani Singh, SO-I only for consideration of enrolment under Old Pension Scheme and allotted U.O. No.168/2024-2025/FD(PIC) dated 02.12.2024 and U.O. No.77/2024-2025/DP dated 20.12.2024 respectively.
- 9. Now, therefore, after due consideration by the Government, it is allowed for counting of service from the first appointment vide order dated 08-03-2000 in respect of Shri Sagolsem Dhanamani Singh, SO-I only for consideration of enrolment under Old Pension Scheme and the above representation is disposed of.
