**ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 16<sup>th</sup> May, 2024

No. 10/19/2013-RD & PR (Pt-II/A): Whereas, the State Cabinet in its decision dated 26.09.2023 has approved for creation of 142 (one hundred forty two) posts of Accountant-cum-Data Entry Operators (ADEOs) under the Directorate of RD&PR, Manipur and regularization & absorption of the 142 (one hundred forty two) ADEOs presently serving on contract basis against these posts.

2. Whereas, the Screening Committee meeting held on 27<sup>th</sup> February, 2024 had recommended for regularization & absorption of 139 (one hundred thirty nine) nos. of Accountant-cum-Data Entry Operators (ADEOs).

3. Whereas, in pursuance of the State Cabinet decision dated 26.09.2023, 142 (one hundred forty two) temporary posts of Accountant-cum-Data Entry Operators (ADEOs) were created in the Directorate of RD&PR, Manipur vide Order No.10/19/2013-RD&PR(Pt-II/A)/I dated 1<sup>st</sup> March, 2024.

4. Whereas, 139 (one hundred thirty nine) nos. of Accountant-cum-Data Entry Operators (ADEOs) were regularized & absorbed against these created posts vide Order No.10/19/2013-RD&PR(Pt-II/A)/II dated 1<sup>st</sup> March, 2024.

5. Whereas, Director (RD&PR), Manipur vide letter No.1/153/83-RD/2012(Pt) dt. 29<sup>th</sup> April, 2024 has reported that the Director (MIS), Manipur has advised Administrative Department to issue order for allocation of these 142 (one hundred forty two) posts of ADEOs in order to process for updation of these 142 new posts of ADEOs in the CMIS data base.

6. Now, therefore, in continuation of this Department's order No. 10/19/2013-RD&PR(Pt-II/A)/I) dated 1<sup>st</sup> March, 2024, the 142 (one hundred fortytwo) temporary posts of Accountant-cum-Data Entry Operators (ADEOs) created under the Directorate of Rural Development & Panchayati Raj, Manipur are hereby allocated to the Block Offices indicated against them as shown in the ANNEXURE.
