THE HIGH COURT OF MANIPUR EMPLOYEES (ANNUAL CONFIDENTIAL REPORT) (FIRST AMENDMENT) RULES, 2022

1. Short title and commencement.-

- (1) These rules may be called "**The High Court of Manipur Employees (Annual Confidential Report) (First Amendment) Rules, 2022**".
- (2) They shall come into force from the date of publication in the Official Gazette of Manipur.

2. Amendment of Rule 11.-
