No. 23/RO-54 NUNGBA/SLAE-2022: In pursuance of Section 31 of the Representation of the People Act, 1951 read with Rule 3 of the Conduct of Election Rules, 1961 and further Notification No. AA-102/1/2021-ELEC-ED dated 4<sup>th</sup> February, 2022 of the Governor of the State of Manipur and Notification No. 464/MR-LA/2022 dated 4<sup>th</sup> February, 2022 of the Election Commission of India, published in the Manipur Gazette Extraordinary No. 408 and No. 409 respectively, both dated 4<sup>th</sup> February, 2022, notice is hereby given that:-

- (1) an election is to be held of a member to the Manipur Legislative Assembly in the **54-Nungba (ST)** Assembly Constituency;
- (2) nomination papers may be delivered by a candidate or by any of his proposers to the Returning Officer or to Mangminlian Vaiphei, Assistant Returning Officer, at the Office Chamber of the Addl. Deputy Commissioner, Tamenglong (1<sup>st</sup> Floor), Mini Secretariat, Tamenglong between 11 A.M. and 3 P.M. on any day (other than public holiday) not later than the 11<sup>th</sup> February, 2022 (Friday);
- (3) forms of nomination paper may be obtained at the place and times aforesaid;
- (4) nomination paper will be taken up for scrutiny at 11 A.M. on the 14<sup>th</sup> February, 2022 (Monday) at the Office Chamber of the Addl. Deputy Commissioner, Tamenglong (1<sup>st</sup> Floor), Mini Secretariat, Tamenglong;

- (5) notice of withdrawal of candidature may be delivered either by a candidate or by any of his proposers or by his election agent who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his office before **3 P.M.** on the **16<sup>th</sup> February**, **2022 (Wednesday)**;
- (6)in the event of the election being contested, the poll will be taken on the 3<sup>rd</sup> March, 2022 (Thursday) between the hours of 7 A.M. and 4 P.M.
