No. 23/RO-54 NUNGBA/SLAE-2022: In pursuance of Section 31 of the Representation of the People Act, 1951 read with Rule 3 of the Conduct of Election Rules, 1961 and further Notification No. AA-102/1/2021-ELEC-ED dated 4th February, 2022 of the Governor of the State of Manipur and Notification No. 464/MR-LA/2022 dated 4th February, 2022 of the Election Commission of India, published in the Manipur Gazette Extraordinary No. 408 and No. 409 respectively, both dated 4th February, 2022, notice is hereby given that :-

- (1) an election is to be held of a member to the Manipur Legislative Assembly in the **54-Nungba (ST)** Assembly Constituency;
- (2) nomination papers may be delivered by a candidate or by any of his proposers to the **Returning Officer** or to **Mangminlian Vaiphei, Assistant Returning Officer**, at the **Office Chamber of the Addl. Deputy Commissioner, Tamenglong (1st Floor), Mini Secretariat, Tamenglong** between **11 A.M. and 3 P.M.** on any day (other than public holiday) not later than the **11th February, 2022 (Friday)**;
- (3) forms of nomination paper may be obtained at the place and times aforesaid;
- (4) nomination paper will be taken up for scrutiny at **11 A.M.** on the **14th February, 2022 (Monday)** at the **Office Chamber of the Addl. Deputy Commissioner, Tamenglong (1st Floor), Mini Secretariat, Tamenglong**;

- (5) notice of withdrawal of candidature may be delivered either by a candidate or by any of his proposers or by his election agent who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his office before **3 P.M.** on the **16th February, 2022 (Wednesday)**;
- (6) in the event of the election being contested, the poll will be taken on the **3rd March, 2022 (Thursday)** between the hours of **7 A.M.** and **4 P.M.**
