NOTIFICATION

Imphal, the 26th May, 2025

No. LA-101/1/2025-REV-REVENUE: The Governor of Manipur is pleased to notify under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the land measuring 7.3556 acres under patta No. 1(Old), 200(New) covered by C.S. Dag No. 1007(New) and 1004 (New) of Revenue village No. 91(A) Lamphelpat, Lamphel Sub-Division, Imphal West district described in the schedule given below are likely to be needed for a public purpose i.e. for expansion of the existing Manipur Zoological Garden, Iroisemba and that the Additional District Magistrate, Imphal West has been appointed as Administrator under section 43 of the said Act for the purposes of Rehabilitation and Resettlement.

- 2. Social Impact Assessment Study was carried out by Social Impact Assessment (SIA) Unit, Manipur and the report has been examined by the Expert Group and its recommendation is found as under:
 - a. The project shall serve public purpose especially Conservation, Education and Recreation.
 - b. The potential benefits outweigh the social cost and adverse social impacts.

"The extent of land proposed to be acquired is the absolute bare-minimum needed for the project and there are less displacing options available".

- 3. Further, the Governor of Manipur is also pleased to authorize the concerned Sub-Divisional Officer(s), Sub-Deputy Collector(s) and staff under their control to take steps under the provisions of section 12 read with section 13 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to submit report to the Collector (LA), Imphal West.
- 4. Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale / purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.
- 5. Objection to the acquisition, if any, may be filed by the person interested within 60 (sixty days) from the date of publication of this notification as provided under section 15 of the Act before Deputy Commissioner/Collector (LA), Imphal West district.
