NOTICE OF ELECTION

No. 1/RO(MAO)/SAE/2022: In pursuance of Section 31 of the Representation of People Act, 1951 read with Rule-3 of Conduct of Election Rules, 1961 and further Notification No. AA-102/1/2021-ELEC-ED dated 4th February, 2022 of the Governor of Manipur and Notification No. 464/MR-LA/2022 dated 4th February, 2022 of the Election Commission of India, published in the Manipur Gazette Extraordinary No. 408 and No. 409 respectively, both dated 4th February, 2022, notice is hereby given that:

- (1) an election is to be held of a member to the **Manipur Legislative Assembly** in the **48-Mao (ST) Assembly Constituency**.
- (2) nomination papers may be delivered by a candidate or by any of his/her proposers to the **Returning Officer** or to **Shri Derick L. Khobung, Assistant Returning Officer**, at the **office chamber of the Addl. Deputy Commissioner, Senapati/Returning Officer, 48-Mao (ST) Assembly Constituency, Room No. 2, First Floor, Block A, Mini-Secretariat, Senapati** between **11:00 A.M. and 3:00 P.M.** on any day (other than public holiday) not later than the **11th February, 2022 (Friday)**.
- (3) forms of nomination paper may be obtained at the place and times aforesaid.
- (4) nomination paper will be taken up for scrutiny at **11:00 A.M. on 14th February 2022 (Monday)** at **office chamber of the Addl. Deputy Commissioner, Senapati/Returning Officer, 48-Mao (ST) AC, Room No. 2, First Floor, Block A, Mini-Secretariat, Senapati**.

- (5) notice of withdrawal of candidature may be delivered either by a candidate or by any of his/her proposers or by his/her election agent who has been authorized in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his office before **3:00 P.M.** on the **16th February, 2022 (Wednesday)**.
- (6) in the event of the election being contested, the poll will be taken on **3rd March, 2022 (Thursday)** between the hours of **7:00 A.M.** and **4:00 P.M.**
