No. 2/6/2023-Leg/L: The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on February 26, 2023 is hereby published in the Official Gazette:

**THE MANIPUR APPROPRIATION (No. 1) ACT, 2023
(MANIPUR ACT NO. 2 OF 2023)**

An

Act

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Manipur for the services of the financial year, 2022 - 23.

Be it enacted by the Legislature of Manipur in the Seventy Fourth Year of the Republic of India as follows:-

1. This Act may be called the Manipur Appropriation (No.1) Act, 2023.

Short Title

2. From and out of the Consolidated Fund of the State of Manipur there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of three thousand one hundred fifteen crore twenty five lakh sixty six thousand rupees towards defraying the several charges which will come in course of payment during the financial year 2022 - 23 in respect of the services specified in column 2 of the Schedule.

3. The sum authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
