NOTIFICATION

Imphal, the 20th May, 2024

No.14/17/2017-HE: Whereas, the State Cabinet in its decision taken on 23.12.2021 has given its approval to the regularization of the service of 9 (nine) Guest Lecturers of D.M College of Teacher Education. However, Chongtham Khogendra Singh, one of these 9 (nine) Guest Lecturers of D.M College of Teacher Education was found to be overaged at the time of initial appointment, therefore, the service of 8 (eight) out of the 9 (nine) Guest Lecturers were regularized vide order No. 14/17/2017-HE dated 07.01.2022;

2. And whereas, Director (Univ. & Hr. Edn.), Manipur vide its letter N.3/90(4)/84-EDC (Pt.II) Vol.II dated 26.03.2021 has reported that Chongtham Khogendra Singh, Guest Lecturer of D.M. College of Teacher Education was overaged by 4 (four) years at the time of appointment as Guest Lecturer after getting 3 (three) years relaxation for OBC Category;

3. And whereas, the matter was referred to Finance Department (PIC) for obtaining its views and comments and Finance Department (PIC) has advised the Administrative Department of Higher & Technical Education for obtaining approval of the State Cabinet for relaxation of age in respect of Chongtham Khogendra Singh, Guest Lecturer, D.M. College of Teacher Education, Imphal. View of the Finance Department (PIC) is reproduced below: -

"AD is advised to place the matter before the "State Cabinet" by highlighting all the relevant facts for taking a considered decision."

4. And whereas, the Department of Personnel was moved for its views/ Comments on the fresh proposal of the verification committee and views of DP has been obtained, the same of which is also cited below:

"The proposal was processed and examined in DP's file No. DR-10/1/2023-DP-DP and as there is no Rules/policy on relaxation of age, DP does not support the proposal. However, DP has no objection in AD placing the proposal before the Cabinet."

5. And whereas, the matter was placed before the State Cabinet and the State Cabinet in its sitting held on 26.09.2023 had approved proposal for relaxation of age in respect of Chongtham Khogendra Singh, Guest Lecturer, D.M. College of Teacher Education, Imphal;

6. Now, therefore, the Governor of Manipur is pleased to order regularization of the service in respect of Chongtham Khogendra Singh, Assistant Professor (M.Ed.), D.M College of Teacher Education,

7. This issues with the concurrence of F.D (PIC) vide their U.O No.125/2023-2024/FD(PIC) dated 21.11.2023 and Department of Personnel (DP) vide their U.O No. 218/2023-2024/DP dated 29.12.2023.
