ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 3rd March, 2023

No. Writ/11/8/2018-HE/Case (Pt.): Whereas, the Administrative Department of Higher & Technical Education, Manipur vide Order No. Writ/11/8/2018-HE/Case (Pt.) dated 22.07.2022 had issued order pertaining to the inclusion of W. Eliza Devi, LDC in the taking over process of the erstwhile Aided Mayai Lambi College, Yumnam Huidrom by the Government;

2. Whereas, subsequent to the inclusion in the taking over, the Administrative Department of Higher & Technical Education, Manipur vide Order No. Writ/11/8/2018-HE/Case (Pt.) dated 25.08.2022 had issued order for the creation of post of L.D.C. and appointment of W. Eliza Devi, LDC of the erstwhile Aided Mayai Lambi College, Yumnam Huidrom by the Government;

3. And, whereas, the Directorate of University & Higher Education, Manipur vide letter No.DUHE-17/15/2021-DUHE-DU&HE dated 13.10.2022 had furnished the re-verification report in respect of W. Eliza Devi, LDC of Mayai Lambi College, Yumnam Huidrom and recommended that the past service and pay including pension and gratuity benefit in respect of the incumbent may also be protected with effect from her initial date of joining i.e. 05.10.2016 as per provisions under clause 7 of Manipur Civil Service (Appointment and Other Service Conditions of employees of Government Aided/Private Institutions taken over by the Government) Rules, 1981 in the pay scale of Rs. 5200-20200+GP Rs. 1900 (Pre-revised) or L-3 of RoP, 2019;

4. And, whereas, the Administrative Department of Higher & Technical Education, Government of Manipur had sought the views of Finance Department (PIC) and FD(PIC) has concurred to the proposal as stated at para (3) above

5. Now, therefore, in continuation of earlier Government Order No. Writ/11/8/2018-HE/Case (Pt.) dated 25.08.2022, the Governor of Manipur is pleased to order to the prescription of Scale of pay in respect of W. Eliza Devi, LDC of Mayai Lambi College, Yumnam Huidrom who was appointed vide Government Order No. Writ/11/8/2018-HE/Case (Pt.) dated 25.08.2022 in the following manner:

6. Further, salary and allowances in respect of W. Eliza Devi, LDC of Mayai Lambi College, Yumnam Huidrom will be paid at the rate already drawn by her under the superseded Governing Body w.e.f. the date of taking over of the College till a day before the creation of post. Actual pay or consequent admissible financial benefits to the newly appointed non-teaching staff on regular basis shall be made w.e.f. the date of post creation and the effective date of appointment shall be considered from the date of issue of post creation order.

7. However, no arrear of Pay for the period from the date of her initial date of joining as furnished by the Verification Committee up to a day before the creation of post shall be claimed/paid.

8. Protection of the past service and pay protection with notional effect including pension and gratuity benefit in respect of W. Eliza Devi, LDC of Mayai Lambi College, Yumnam Huidrom, the same of which will be counted as experience or service required for promotion or direct recruitment as the case may be from the date of her joining. Further, the provisions of the National Pension System shall be applicable to her as she has been appointed after 01.01.2005 by the then Governing Body.
