ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 26th March, 2022

No. CCs-1012/2/2021-HTE-DHTE: Whereas, consequent upon the taking over of 11 (eleven) teaching & non-teaching staff of erstwhile Aided Thambal Marik College, Oinam by the Government vide Order No. CCs-1012/2/2021-HTE-DHTE(A) dated 29.07.2021, Post creation order was issued vide Order No. CCs-1012/2/2021-HTE-DHTE(B) dated 29.07.2021 subject to the following condition:

"Further, the creation of 5 (five) nos. of supernumerary posts of 'Lecturer' in the pay scale of Rs. 9300-34800+ GP Rs. 4400/- shall be with immediate effect for the period upto 28.02.2021 to fit the 5 unqualified teachers in the newly created posts. However, on possessing the requisite educational qualification for the post of Assistant Professor, the said Lecturers may be upgraded to the post of Assistant Professor and the post of Lecturers held by him/her be abolished."

2. and whereas, necessary verification in respect of staff of 6 (six) Aided Colleges were undertaken and Dr. Kh. Gourachand Singh was appointed as 'Lecturer in Political Science' vide Government Order No. CCs-1012/2/2021-HTE-DHTE dated 04.08.2021 under the category 'Unqualified (Unapproved)' as per the Verification report of the Verification Committee and with due concurrence of the Finance Department (PIC) subject to the condition cited below:

"On possessing the requisite educational qualification for the post of Assistant Professor, the said Lecturers may be upgraded to the post of Assistant Professor created vide Order No. CCs-1012/2/2021-HTE-DHTE(B) dated 29.07.2021 and the post of Lecturers held by him/her be abolished."

3. and whereas, the Director (Univ. & Hr. Edn.), Manipur vide letter No. 3/3-36/15-UHE(Pt-I)(Vol VI) dated 28.09.2021 had furnished a verification sheet of the Verification Committee in respect of the aforementioned incumbent;

4. and whereas, the matter was referred to Finance Department (PIC) for their views/comments and views of FD(PIC) is reproduced below:

“As per the recommendation of the Verification Committee in its report dated 28.09.2021 and AD’s Order dated 04.08.2021, Finance Department (PIC) agrees to the upgradation of the qualification status in respect of Dr. Kh. Gourachand Singh, Lecturer in Political Science of Thambal Marik College from the existing Lecturer to Assistant Professor in Political Science in PB-3: Rs. 15600-39100+AGP Rs. 6000 on possessing the requisite education qualification i.e. Ph.D. Degree w.e.f. 25.01.2008 subject to abolishment of the existing post of Lecturer held by him”

5. Now, therefore the Governor of Manipur is pleased to order the upgradation/rectification of the post of Lecturer (Political Science) in respect of Dr. Kh. Gourachand Singh of Thambal Marik College as ‘Assistant Professor’ in PB-3: Rs. 15600-39100+AGP Rs. 6000 on having acquired the requisite education qualification subject to abolishing of existing Lecturer in Botany post held by him.

6. This issues with the concurrence of the Finance Department (PIC), Government of Manipur vide their UO No. 210/2021-2022/FD(PIC) dated 24.12.2021.
