ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 9th July, 2024

No. UHE-101/88/2023-HTE-DHTE: Whereas, consequent upon the taking over of 6 Aided Colleges namely, (1) Biramangol College, Sawombung, (2) Kakching Khunou College, Kakching Khunou, (3) Liberal College, Luwangsangbam, (4) Mayai Lambi College, Yumnam Huidrom, (5) Standard College, Kongba & (6) Thambal Marik College, Oinam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018, the Administrative Department had appointed 478 (four hundred and seventy eight) numbers of teaching staff and 163 (one hundred and sixty three) numbers of non-teaching staff vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, 06 (six) Teaching and 07 (seven) Non-teaching staff vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 (Age Bar) dated 26.05. 2020 & 11 (eleven) teaching staff & non-teaching staff vide Government Order No. CCs-1012/2/2021-HTE-DHTE dt. 04.08.2021 of the erstwhile 6 (six) aforementioned Aided Colleges into Government service with due concurrence of Finance Department (PIC);

- 2. And whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE/2015/18/2023-DUHE-DU&HE dated 23.10.2023 has furnished a report of the Verification Committee dated 23.10.2023 regarding the re-verification of service records in respect of 10 (ten) teachers of Biramangol College, Kakching Khunou College, Standard College and Thambal Marik College who were initially appointed as Lecturers under the category Un-qualified / Un-approved staff at the time of taking over by the Government vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, No. 31/3/AIDED-COL/CONVSN/HE-16 (Age Bar) dated 26.05. 2020 & No. CCs-1012/2/2021-HTE-DHTE dt. 04.08.2021;
- 3. And whereas, 10 (ten) teaching staff as listed in the table below at para 5 have been appointed vide Government Order Government vide Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, No. 31/3/AIDED-COL/CONVSN/HE-16 (Age Bar) dated 26.05. 2020 & No. CCs-1012/2/2021-HTE-DHTE dt. 04.08.2021 with due concurrence of Finance Department (PIC) under the category Un-qualified / Un-approved staff at the time of taking over by the Government without categorization of unqualified phase as Lecturer & qualified phase as Assistant Professor;

- 4. And whereas, after examination of the proposal for rectification of the service records in respect of these 10 (ten) teachers, the matter was referred to Finance Department (PIC) for concurrence to the proposal of the Verification Committee and FD (PIC) has concurred to the rectification of FD's earlier concurrence in connection with the appointment in respect of 10 (ten) teaching staff of the aforementioned 04 (four) newly converted Government Colleges;
- 5. Now, therefore, in partial modification of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019, No. 31/3/AIDED-COL/CONVSN/HE-16 (Age Bar) dated 26.05. 2020 & No. CCs-1012/2/2021-HTE-DHTE dt. 04.08.2021, the Governor of Manipur is pleased to order the rectification of effective date of qualified/unqualified status in respect of 10 (ten) teaching staff of the aforementioned 04 (four) erstwhile Government Aided Colleges now converted into full-fledged Government Colleges and the corrected list of staff along with their details as concurred by the Finance Department (PIC) in respect of the 10 (ten) teaching staff are detailed in the Table below:
