ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 15th March, 2024

No.UHE-1/7/2023-HTE-DHTE : Whereas, consequent upon the taking over of 4 (four) Aided Colleges namely, (1) Moreh College (MC), Moreh, (2) S. Kula Women's College (SKWC), Nambol, (3) South East Manipur College (SEMCO), Komlathabi and (4) Waikhom Mani Girls' College (WMGC), Thoubal and their conversion into full-fledged Government Colleges vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 29.01.2020, the Administrative Department had appointed 317 (three hundred and seventeen) numbers of teaching staff and 154 (one hundred and fifty four) numbers of non-teaching staff of the erstwhile 4 (four) aforementioned Aided Colleges into Government service vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/25/2019-HE(4Aided) dated 15.04.2021 with due concurrence of Finance Department (PIC);

2. And whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-2015/5/2023-DUHE-DU&HE dated 27.06.2023 had furnished a report of the Verification Committee dated 27.06.2023 on the re-verification of service records in respect of 4 (four) Teaching staff of S.K. Women's College, Waikhom Mani Girls' College and Moreh College who were initially appointed as 'Lecturer' under the category Un-qualified (both Approved & Un-approved) staff at the time of taking over by the Government & Un-qualified (Un-approved) staff at the time of taking over by the Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/25/2019-HE(4Aided) dtd. 15.04.2021;

3. And whereas, the aforementioned 04 (four) Lecturers mentioned at para 2 above as listed in the table below at para 5 have been appointed as 'Lecturers' under the category Un-qualified (both Approved & Un-approved) staff at the time of taking over by the Government & Un-qualified (Un-approved) staff at the time of taking over by the Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/25/2019-HE(4Aided) dtd. 15.04.2021 with due concurrence of Finance Department (PIC) without categorization of un-qualified phase as Lecturer & qualified phase as Assistant Professor;

4. And whereas, after examination of the proposal for rectification of qualification status in respect of these 04 (four) Lecturers, the matter was referred to Finance Department (PIC) for the concurrence to the proposal of the Verification Committee and FD (PIC) has concurred to the upgradation of qualification status in respect of the 04 (four) teaching staff from Lecturers to Assistant Professors (i.e. PB-3: Rs. 15600-39100+AGP Rs.6000/-) on acquiring the requisite qualification i.e. Ph.D Degree subject to the abolishment of existing posts of Lecturers held by them;

5. Now, therefore, in partial modification of Government Order No. 31/3/AIDED-COL/CONVSN/HE-16(MSSW) dated 10.08.2020 and No. 14(9)/25/2019-HE(4Aided) dated 15.04.2021, the Governor of Manipur is pleased to order the rectification/upgradation of qualification status in respect of the 04 (four) teaching staff from Lecturers to Assistant Professors (i.e. PB-3: Rs. 15600-39100+AGP Rs.6000/-) on acquiring the requisite qualification i.e. Ph.D Degree subject to the abolishment of existing posts of Lecturers held by them as detailed in the table below:
