**No. CCs-1011/1/2021-HTE-DHTE:** Whereas, the Administrative Department of Higher & Technical Education, Manipur vide Order No. CCs-1011/1/2021-HTE-DHTE(A) dated 16.02.2021 had issued an order pertaining to the taking over of following 7 (seven) teaching staff of erstwhile Aided Mayai Lambi College, Yumnam Huidrom by the Government:

2. and whereas, 7 (seven) supernumerary posts of 'Lecturer' were created to fit the 7 (seven) unqualified (unapproved) teachers vide Order No. CCs-1011/1/2021-HTE-DHTE(B) dated 16.02.2021;

3. and whereas, the aforesaid 7 (seven) teaching staff of the said College were appointed vide Order No. CCs-1011/1/2021-HTE-DHTE dated 22.02.2021 as 'Lecturer' in their respective subject against the post created vide Order No. CCs-1011/1/2021-HTE-DHTE(B) dated 16.02.2021;

4. and whereas, the Director, University & Higher Education, Manipur vide letter No. 3/3-36/15-UHE(Pt-I)(Vol. III) dated 10.03.2021 had furnished the re-verification report of the aforementioned 7 (seven) Lecturers of erstwhile Aided Mayai Lambi College, Yumnam Huidrom and recommended the said 7 Lecturers as 'Assistant Professor' on having acquired the requisite qualifications as per relevant RRs/norms as the 1997 RR notified on 15.01.1997 was kept in abeyance vide Order no. 1/10/67/RR/DP(Pt) dated 10.02.1998 thus reviving the 1989 RR from 10.02.1998 till notification of 1998 RR on 24.09.1998;

5. and whereas, the Administrative Department of Higher & Technical Education, Manipur had sought the views of Finance Department (PIC) and views of the Finance Department (PIC) is reproduced below:

*"As per Cabinet decision taken on 19.12.2020 and Verification Committee's report dated 10.03.2021, FD(PIC) allots U.O. 354/2020-2021/FD(PIC), dated 22.03.2021 No. to the absorption/appointment of following 7 (seven) left out teaching staff of erstwhile Mayai Lambi Aided College (now Govt. College) against the newly created post at Column (3).*

3. Further, the other service conditions (except actual pay or consequent admissible financial benefits) shall be remained same as done earlier case of teaching staff of Mayai Lambi College."

6. and whereas, as concurred by Finance Department (PIC) in the manner as stated in Para 5 above, the Administrative Department vide Order No. CCs-1011/1/2021-HTE-DHTE dated 25.03.2021, had issued an order pertaining to the rectification of their Qualification status and appointment as 'Assistant Professor' in their concerned subject on having acquired the requisite educational qualification subject to abolishing of existing Lecturer post held by them in the concerned subjects;

7. and whereas, the Director of Univ. & Hr. Edn. vide letter No. DUHE-17/15/2021-DUHE-DU&HE dated 06.04.2022 had furnished a fresh re-verification report wherein it is stated that the 1997 RR notified vide Order no. 1/10/67/RR/DP(Pt) dated 15.01.1997 was kept in abeyance vide Order no. 1/10/67/RR/DP(Pt) dated 10.02.1998 thus reviving/enforcing the 1989 RR from 26.02.1998 (date of publication in Gazette) till notification of 1998 RR on 24.09.1998;



8. and whereas, the matter was referred to Finance Department (PIC) and FD(PIC) had agreed to the rectification of the appointment of the aforementioned 7 teaching staffs in the manner as reproduced below:

9. and whereas, the Hon'ble High Court in its order dated 20.09.2018 had directed the State Government as reproduced below:

*"Accordingly, the present petition is disposed of with the direction to the respondents authority more particularly the State Government to absorb the services of the petitioners as Government employees as had been done in respect of other teaching and non-teaching staffs of the College upon conversion of the Mayai lambi College as a Government College after making necessary verification of the service records which exercise shall be completed within a period of 5 (five) months from today."*

10. Now therefore in continuation of earlier Government Order No. CCs-1011/1/2021-HTE-DHTE dated 22.02.2021 and also in supersession of Government Order No. CCs-1011/1/2021-HTE-DHTE dated 25.03.2021, the Governor of Manipur is pleased to order the rectification of Qualification status in respect of the aforementioned 7 (seven) teaching staff of Mayai Lambi College in the manner as concurred by Finance Department (PIC), as stated in Para 8 above.

11. Further, salaries and allowances of all the existing staff of the College will be paid at the rate already drawn by them under the superseded Governing Body w.e.f. the date of taking over the college till a day before the creation of post(s). Actual pay or consequent admissible financial benefits to the newly appointed Assistant Professors/ Lecturers on regular basis shall be made w.e.f. the date of post creation and the effective date of appointment shall be considered from the date of issue of Post creation order.

12. However, no arrear of Pay for the period from the date of their initial date of joining as furnished by the Verification Committee upto a day before the creation of post(s) shall be claimed/paid.

13. Protection of the past service and pay protection with notional effect including pension and gratuity benefit in respect of the 7 (seven) Teaching Staff of the Mayai Lambi College, the same of which will be counted as experience or service required for promotion or direct recruitment as the case may be from the date(s) of their joining. Further, the provisions of the National Pension System shall be applicable to those employees of the Colleges who have been appointed on or after 01.01.2005 by the then Governing Body.
