ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 23rd May, 2022

No. UHE-18022/2/2021-HTE-DHTE:

Whereas, consequent upon the taking over of Jiri College, Jiribam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 2/11/Jiri Col/Conv./HE-16 dated 02.03.2019, the Administrative Department had appointed S. Ibemtombi Devi as 'Lecturer in Manipur' under the category 'Unqualified (Unapproved) staff' in Jiri College, Jiribam vide Government Order No. 2/11/Jiri Col/Conv./HE-16 dated 07.03.2019 read with Order No. 2/11/Jiri Col/Conv./HE-16(C) dated 15.06.2020 with due concurrence of Finance Department (PIC) and provided with an opportunity to acquire the necessary minimum qualification as per relevant UGC norms within a period of 5 years;

2. An whereas, as approved by the State Cabinet in its sitting held on 20.04.2020, the Administrative Department of Higher Education, Manipur vide Order No. 31/3/AIDED-COL/CONVSN/HE(EIN) dated 27.05.2020 had created 71 supernumerary post of Lecturers for 71 Lecturers of 7 erstwhile Aided Colleges, including S. Ibemtombi Devi of Jiri College, Jiribam, in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- to fit the unqualified teachers in the newly created posts subject to the following conditions:

- i) To freeze the 71 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite education qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.
- iii) The Lecturers who are not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 - 34, 800/- plus FP of Rs. 4400/- p.m. till they get qualified as per the existing recruitment rules by giving them one time opportunity to improve their educational qualification to pursue either NET/M. Phil/Ph. D. Degrees as the case may be, as per relevant UGC norms within the period of 5 (five) years from the date of issue of order for conversion into full-fledged as done in the case of regularisation of 418 Part-time Lecturers vide Government order No.7(2)/9/2005-S/HE(Pt. III) dated 12.04.2017. After improving themselves upto their requisite educational qualification i.e. either M. Phil or NET or Ph. D. Degrees, they shall be entitled for the pay-scale of PB-3: Rs. 15,600-39,100 plus AGP of Rs.6000/- p.m. with the designation as Assistant Professors in parity with qualified Assistant Professors.

3. and whereas, the Director of University & Higher Education, Manipur vide her letter No. 3/3-36/15-UHE(Pt-III) dated 09.07.2021 had furnished a re-verification report of the Verification Committee regarding the upgradation of status of qualification in respect of S. Ibemtombi Devi of Jiri College, Jiribam on having acquired Ph. D. Degree in the year 20.09.2019 from Assam University;

4. and whereas, after careful examination, the matter was referred to Finance Department (PIC) and FD (PIC) has concurred to the rectification of qualification status of S. Ibemtombi Devi of Jiri College, Jiribam as cited below:

"As per the recommendation of the Verification Committee and conditions at Para 9 of the Government's order dated 27.05.2020, FD (PIC) agrees to the upgradation of qualification status of Smt. Sagapam Ibemtombi Devi, Lecturer in Manipuri, Jiri College from Lecturer to Assistant Prof. in PB-3: Rs. 15600-39100+AGP 6000/- on having acquired the requisite qualification i.e. Ph. D. Degree w.e.f. 20.09.2019 i.e. the date of passing/declaration of Ph.D. Degree from Assam University subject to abolishing of existing Lecturer post held by her."

5. Now therefore, the Governor of Manipur is pleased to order the upgradation/re-designation of the post of 'Lecturer in Manipuri' in respect of S. Ibemtombi Devi of Jiri College, Jiribam as Assistant Professor in PB-3: Rs. 15600-39100+AGP Rs. 6000 on having acquired the requisite educational qualification w.e.f. 20.09.2019 i.e. the date of passing/declaration of Ph.D. Degree subject to abolishing of existing Lecturer in Botany post held by her.

6. This issues with the concurrence of Finance Department (PIC), Government of Manipur vide their U.O. No. 183/2021-2022/FD(PIC) dated 03.12.2021.
