**NOTIFICATION**

Imphal, the 3<sup>rd</sup> April, 2023

**No.1/16/2016-FD(PIC)** : In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules further to amend the Manipur Services (Revised Pay) Rules, 2019, namely –

1. (1) These rules may be called the Manipur Services (Revised Pay) (6<sup>th</sup> Amendment) Rules, 2023.  
(2) The revised Pay Matrix appearing in Col. (4) of SECTION – III of THE FIRST SCHEDULE, PART – B, SECTION – III to the Manipur Services (Revised Pay) Rules, 2019 in respect of certain posts are further revised and corresponding revised Pay Band and Grade Pay have been prescribed in the ANNEXURE to this Notification.
2. (1) These revised Pay Band and Grade Pay shall be effective notionally from 01/01/2016 and cash payment from 01/03/2023.  
(2) In respect of those posts for which amendment of Recruitment Rules were notified after 01/01/2016, the revised Pay Band and Grade Pay shall be effective notionally from the date of publication of notified / amended Recruitment Rules in the Manipur Gazette as indicated in the Remarks column of the respective posts with cash payment from 01/03/2023.  
(3) In respect of those posts for which rectification of Pay Anomaly of the various posts of Integrated Child Protection Scheme (ICPS) viz. Manager/ Coordinator (SAA), District Child Protection Officer (DCPO), Protection Officer and Legal-cum-Probation Officer subject to the framing of relevant Recruitment Rules, the pay already enjoyed may be protected as personal pay till the next revision.
