No. AG-2/2/2021-SEC-LAW: In pursuance of decision of State Cabinet in its Meeting held on 04-01-2022, the Governor of Manipur is pleased to order that the terms and conditions and rates of fees payable to Additional Advocate General, Manipur payable by State Government Departments will be at the rates given below with immediate effect:

- In respect of fees at SI. no. 2 to 8 and appearance fee of Jr. Advocate at SI. no. 11 of first para, the fees are payable by concerned Administrative Departments and Directorates involved in the Court cases from their respective annual budget.
