ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 13th May, 2022

No. UHE-18014/1/2020-HTE-DHTE: Whereas, the Commissioner of Higher & Technical Education, Manipur had issued a strict instructions, vide U.O. No. 1/Com.Hr.&Tech.Edn./Scert & AE/2013 dated 06.05.2013 to all concerned Directors, Officers, Principals of Government Colleges and the Presidents of AMCTA & AMGOCTA and other Teacher's Associations in Manipur to not accept/honour any illegal degrees/Certificates including M. Phil(s) & Ph.D(s) awarded by Chandra Mohon Jha (CMJ) University, Meghalaya, Shillong during the year 2021-2013 to many students from the State of Manipur;

2. and whereas, the Administrative Department of Higher & Technical Education, Manipur had issued orders vide i) No. 7(16)2003-S/HE(Misc) dated 27.02.2017 in respect of 8 (eight) Colleges teachers, ii) No. 7(7)/15/2018-HE/ADV dated 27.06.2020 in respect of Shri Lamabam Mahendro Singh, Associate Professor in English & iii) No. UHE-18010/2/2021-HTE-DHTE dated 18.08.2021 in respect of 8 (eight) teachers of erstwhile Aided Colleges pertaining to the genuineness/legitimate Certificates of M. Phil/Ph.D. Degrees, on having acquired their Ph. D. Degrees from CMJ, University, for the purpose of their services in the Government/Government Aided Colleges but subject to the conditions that such College Teachers shall not pursue other higher degree's courses from CMJ, University without prior written permission of the Government;

3. and whereas, Deputy Secretary to the Government of Meghalaya, Education Department had informed that the matter pertaining to dissolution of CMJ University is at present subjudiced in the Court of Law;

4. and whereas, the Director of University & Higher Education, Manipur vide letter No. DUHE-17/7/2022-DUHE-DU&HE dated 10.02.2022 had furnished a proceeding of the Verification Committee wherein L. Nolini Chanu, Lecturer (Philosophy) of Liberal College, Luwangsangbam is reported to be qualified to be appointed as Assistant Professor w.e.f. 08.09.2021 i.e. the date of passing Ph.D. Degree as per 2010 RR;

5. and whereas, L. Nolini Chanu had acquired her Ph. D. Degree from Chandra Mohon Jha (CMJ) University, Meghalaya, Shillong as detailed below:

6. and whereas, L. Nolini Chanu had registered for Ph. D. Programme (Column III of Table at Para 5 above) in CMJ University, Meghalaya before the issue of U.O. No. 1/Com.Hr.&Tech.Edn./Scert & AE/2013 dated 06.05.2013 on the dubious nature of the University;

7. and whereas, the Registrar of CMJ University, Meghalaya vide letter No. CMJU/RO/VERI/01-2022/212/213 dated 06.01.2022 had also verified and intimated the OSD of Directorate of University & Higher Education, Manipur that the Ph. D. Degree awarded to the aforementioned candidate is correct and genuine;

8. Now, therefore, the Governor of Manipur is pleased to order partial modification to Government's instructions vide U.O. No. 1/Com.Hr.&Tech.Edn./Scert&AE/2013 dated 06.05.2013 regarding the BAN on M.Phil/Ph.D. Degree Certificates awarded by CMJ University, Meghalaya in respect of L. Nolini Chanu, Lecturer (Philosophy) of Liberal College, Luwangsangbam in consideration of the Verification report of the Verification Committee vide letter dated 10.02.2022 and the verification report furnished by the Registrar, CMJ University, Meghalaya vide letter dated 06.01.2022 on the genuineness of the certificate of the aforementioned 8 Lecturers.

9. The Government is further pleased to order that the Certificate of Ph. D. Degree awarded by CMJ, University, Meghalaya in favour of L. Nolini Chanu, Lecturer (Philosophy) of Liberal College, Luwangsangbam, shall be treated as legal/genuine/legitimate Certificates in the State of Manipur for the purposes of their services in the Government/Government Aided Colleges but subject to the conditions that the said Lecturers shall not pursue other higher degree courses from CMJ University, Meghalaya without prior written permission of the Government.

10. This Order is issued in compliance with the Hon'ble Supreme Court of India's Order passed on dated 13/09/2013 in Spl. Leave to Appeal (Civil) No. 19617/2013 (C.M.J foundation & Ors Vrs- State of Meghalaya).
