NOTIFICATION

Imphal, the 14<sup>th</sup> August, 2024

**No. 1/49/15-SR(MJS)/DP :** In exercise of the powers conferred by the Proviso to Article 309 read with Article 234 of the Constitution of India, the Governor of Manipur is, in consultation with the High Court of Manipur and the Manipur Public Service Commission, pleased to make the following rules further to amend the Manipur Judicial Service Rules, 2005, namely:

1. **Short title and commencement:** (1) These rules may be called the Manipur Judicial Service (Tenth Amendment) Rules, 2024.

(2) These Rules shall come into force on the date of publication in the official gazette of Manipur.

2. In rule 19A, the figures "58" appearing in first and second sentences shall be substituted by the figure "60".

3. The entire text of rule 19B shall be deleted.

4. In rule 20(1), after the first sentence, the following shall be added, "The review shall be made on the basis of the Officer's past record of service, character roll quality of judgments and other relevant matters."

Further in 20(2), the figures and word "50 and 55" shall be substituted by the figures and word "50, 55 and 58".

5. In rule 21(iii), the word "not" shall be inserted between the words "The Officer had" and "sought voluntary retirement"

6. After rule 22, the following proviso may be added:

"Provided that the benefits of number of years of practice at bar subject to maximum of weightage of ten years will be given to direct recruits of Grade-I Service who retired prior to 01.01.2016."

**7. Amendment of SCHEDULE-A:**

The SCHEDULE-A appended to the Principal Rules shall be substituted by the following, namely:

**“SCHEDULE-A”**

There shall be three Grades of Service, namely:

- (a) **Grade-I**
- (b) **Grade-II**
- (c) **Grade-III**
