**NOTIFICATION**

Imphal, the 15<sup>th</sup> March, 2024

RRDP-27/1/2021-DP-DP: In exercise of the powers conferred by the Proviso to Clause (3) of Article 320 of the Constitution of India, read with the decision of the State Cabinet in its meeting held on 14.03.2024, the Governor of Manipur hereby makes the following regulation further to amend the Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972 namely:-

**1. SHORT TITLE AND COMMENCEMENT:**

- (1) These regulations may be called the Manipur Public Service Commission (Exemption from Consultation) (Amendment) Regulations, 2024.
- (2) They shall come into force on the date of their publication in the Official Gazette.

**2. Addition of Regulation 135 – After regulation 134 of the Manipur Public Service Commission (Exemption from consultation) Regulations, 1972, the following regulation shall be added, namely:**

"135 It shall not be necessary to consult the Commission (MPSC) with regard to Amendment of Manipur Health Service Rules,1982 for the following amendment:

(a) The existing Rule 7(3)(d) of the Manipur Health Service Rules,1982 shall be substituted by the following: -

"Rule 7(3)(d): "100% of the Specialist Post of Consultant in MHS Grade-I shall be filled by promotion from amongst MHS Grade II officers with PG qualification prescribed in Part A or B or C of Annexure to Schedule II and with 5 years regular service in the Grade".

(b) The existing Rule 7(3)(e)(I) of the Manipur Health Service Rules,1982 shall be substituted by the following: -

"Rule 7(3)(e)(I): "The post of Additional Director of Medical and Health Services in MHS Grade-I, shall be filled by promotion from amongst MHS Grade-II officers with 5(five) years regular service in the grade and who possess any of the qualification in Part A or B or C of Annexure to Schedule II".

(c) The existing Rule 7(3)(e)(II) of the Manipur Health Service Rules,1982 shall be substituted by the following: -

“Rule 7(3)(e)(II): “The post of Director of Medical and Health Services, Director of Family Welfare Services and OSD in MHS Special Grade shall be filled by promotion from MHS Grade-I officers with Post Graduate qualification in Part A or B or C of Annexure to Schedule II with 3 years regular service in the grade.

Failing which by promotion from MHS Grade-I officers with Post Graduate qualifications in Part A or B or C of Annexure to Schedule II with 8(eight) years regular service in MHS Grade-I and MHS Grade-II together with at least 1(one) year in MHS Grade-I”
