(2) Nomination papers may be delivered by a candidate or by any of his proposer to the Returning Officer or to the Assistant Returning Officer at the office of the Returning Officer/SDO, Moirang between 11 AM and 3 PM on any day (other than public holiday) not later than 3-8-2012 (Friday).

(3) Forms of nomination paper and information regarding reservation for SC, ST, women etc may be obtained at the place and time aforesaid.

(4) The nomination papers will be taken up for scrutiny on 4-8-2012 (Saturday) at 10:30 AM at Returning Officer/SDO, Moirang Office.

(5) Notice of withdrawal of candidature may be delivered either by a candidate or by his election agent who has been authorized in writing by the candidature to deliver it to either of the officers specified in paragraph (2) above SDO/RO office before 3 PM on 7-8-2012 (Tuesday) and

(6) In the event of the election being contested the poll will be taken on 13-9-2012 (Thursday) between the hours of 7 AM and 4 PM.
