Imphal, the 5th May, 2010

Subject : - Revision / modification of pension of pre-2006 Pensioners / family pensioners etc.

No.9/2/2010-FD(PIC) : The undersigned is directed to say that, in pursuance of Government's decision following the introduction of the Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to introduce the following modifications in the rules regulating pension, DCRG and Family Pension under the Manipur Civil Services (Pension) Rules, 1977 (hereinafter referred to as Pension Rules) and Commutation of Pension under the Central Civil Services (Commutation of Pension) Rules, 1981 for implementation to the retired Government employees of the State Government.

2. These orders apply to all pensioners/family pensioners who were drawing pension/family pension on 01/01/2006 under the Manipur Civil Services (Pension) Rules, 1977 and the Manipur Services (Extraordinary Pension) Rules, 1995.

3. In these orders:

- (a) Existing pensioner or Existing Family pensioner means a pensioner who was drawing/entitled to pension/family pension on 31/12/2005.
- (b) Existing pension means the basic pension inclusive of commuted portion, if any, due on 31/12/2005. It covers all classes of pension under the Manipur Civil Services (Pension) Rules, 1977 as also Disability Pension under the Manipur Services (Extraordinary Pension) Rules, 1995.
- (c) Existing family pension means the basic family pension drawn on 31/12/2005 under the Manipur Civil Services (Pension) Rules, 1977, as amended.

4.1 The pension / family pension of existing pre-2006 pensioners / family pensioners will be consolidated with effect from 01/01/2006 by adding together:-

- (i) Result of multiplication of existing pension / family pension by a factor of 1.86 and rounded off to next multiple of 10 ; and
- (ii) Fitment weightage @ 40% of the existing pension / family pension.

The amount so arrived at will be regarded as consolidated pension / family pension with effect from 01/01/2006, notionally with effect from 01/01/2006 with cash payment / actual benefit from 01/04/2010.

4.2 Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursements.

4.3 The upper ceiling on pension/family pension shall be 50% and 30% respectively of the highest pay in the Government.

available on the pension payment order, the additional pension / family pension in terms of para 4.4 above may also be paid by the Pension Disbursing Authorities **immediately on receipt of authorization from the Treasury concerned**. A suitable entry regarding the revised consolidated pension shall be recorded in both halves of the Pension Payment Order.

8. The consolidated pension/family pension as worked out in accordance with provisions of Para 4.1 above shall be treated as final 'Basic Pension' with effect from 01/01/2006 and shall qualify for grant of Dearness Relief sanctioned on or after 01/04/2010.
