No. 1/3/2010-FD(EXP)/DFPR: In exercise of the powers conferred by Clause (3) of Article 166 of the Constitution, the State Government hereby makes further amendment to the ‘**Delegation of Financial Powers Rules, 1995**’ of the Government of Manipur namely:-

No. 67

Page 80 of the “Delegation of Financial Power Rule, 1995”
as incorporated in the Manual of Financial Procedure, 1999;
