The State Seed Certification Committee shall recommend the procedures and standards for certification, tests and analysis of seeds, help in planning districtwise varieties of crops to be grown and certified. Further, the Committee also shall ensure proper functioning of the Seed Certification Cell as an Agency as per Seed Act, 1966 and Seed Rule 1968.

3. The functionaries in the Seed Certification Cell shall discharge their duties as indicated against each in addition to their normal duties without any extra remuneration.
