No. 2/11/2013-TA&Hills: In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the Proviso to section 32 of the Manipur (Hill Areas) District Councils Act, 1971 read with rules 45 of the Manipur (Hills Areas) District Councils Rules, 1972, the Governor of Manipur hereby makes the following rules, namely:—

- 1. Short title & commencement : (i) These rules may be called the Manipur (Hills Areas) District Councils (HEADMASTER/HEADMISTRESS (PRIMARY SCHOOL) Recruitment Rules, 2013.
 - (ii) These shall come into force with effect from the date of publication in the Manipur Gazette.
- 2. Application: These rules shall apply to the posts specified in column 1 of the Tribal Affairs & Hills Department Form annexed as Annexure I hereto.
- 3. Classification, scale of pay, Method of engagement, etc. Classification of the said post, scale of pay, method of engagement and other matters connected therewith shall be specified in columns 3 to 12 of the said Tribal Affairs & Hills Department Form hereto.
- 4. Disqualification: No person
 - (a) Who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and
 - (b) No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post,

Provided that the Governor may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of the rule.

- 5. Power to relax: Where the Governor is of the opinion that it is necessary of expedient so to do, he may be order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons of posts.
- 6. This notification is issued in consultation with (DP), Govt. of Manipur.
