**THE MANIPUR APPROPRIATION (No. 2) BILL, 2019**  
(As introduced in the Legislative Assembly, Manipur on 04-03-2019)

A  
BILL

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Manipur for the services of the financial year, 2019-20.

Be it enacted by the Legislature of Manipur in the seventieth year of the Republic of India as follows:-

1. This Act may be called the Manipur Appropriation (No. 2 ) Act,2019.

Short Title

2. From and out of the Consolidated Fund of the State of Manipur there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of sixteen thousand one hundred sixteen crores seventy one lakhs seventy five thousand rupees towards defraying the several charges which will come in course of payment during the financial year 2019-20 in respect of the services specified in column 2 of the Schedule.

3. The sum authorized to be paid and applied from and out of the Consolidated Fund of the State of Manipur by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

4. References to Departments in the Schedule are to such Departments as existing immediately before the 1st day of March, 2019 and shall, on or after that date be construed as references to the appropriate Departments as reconstituted from time to time.

Out of the above amount, a sum of ₹1686,99,82,000/- represents the expenditure charged on the Consolidated Fund and the balance of ₹14429,71,93,000/- voted by the Legislative Assembly.
