OFFICE MEMORANDUM

Imphal, the 26th March, 2011.

Subject :- Clarification on revision of provisions regulating Pension / Gratuity / Commutation of Pension / Leave Encashment / Family pension / Disability Pension of post 01/01/2006 Pensioners / Family Pensioners and Revision / Modification of Pension of pre-2006 Pensioners / Family Pensioners.

No.9/3/2010-FD(PIC)(Pt): In supersession of para 5 of Office Memorandum No.9/3/2010-FD(PIC), dated 16/11/2010 on the above subject, the undersigned is directed to clarify as follows :-

5. (i) Pension / Family Pension / Retirement Gratuity / Death Gratuity / Commutation of Pension / Leave Encashment of the Government employees who retired / died in harness during the period from 01/01/2006 to 31/03/2010 shall be calculated on the basis of the notional pay w.e.f. 01/01/2006 or from the date of retirement or death, whichever is later, or on the basis of the actual emolument drawn in the pre-revised pay scales under the Manipur Services (Revised Pay) Rules, 1999, whichever is more beneficial to the incumbent. The difference of the amount between the pre-revised rate and the revised rate of one-time payment like, Retirement Gratuity / Death Gratuity / Commutation of Pension / Leave Encashment, if found more beneficial, shall be paid. In such cases, the concerned Head of Office / Drawing & Disbursing Officer shall issue a revised Last Pay Certificate (LPC) on the basis of revised Pay Band + Grade Pay along with the notional rate of Dearness Allowance entitled to him / her on the date of retirement / death. The pre-revised rates of other allowances like, House Rent Allowance (HRA), Special Compensatory Allowance (SCA), Non-Practicing Allowance (NPA), Washing Allowance (WA), Transport Allowance (TA), Secretariat Duty Allowance (SDA), Family Planning Allowance (FPA), if any, which were in force prior to 01/04/2010 shall be taken into account while preparing the Revised Last Pay Certificate.
- (ii) In the case of the Government servants who retired / expired during the period from 01/01/2006 to 31/03/2010 in the pre-revised scale of pay which has been protected as a scale personal to them till they cease to hold the post or till the next revision of pay scales takes place, whichever is earlier, in terms of the Manipur Services (Revised Pay) (2nd Amendment) Rules, 2006, regulation

of pay in the corrected pay scale from 01/01/1996 or from the later date, as the case may be, shall not be carried out since recast / regulation of pay in the corrected pay scales is required only for the purpose of revision of pay scales as clarified vide Explanation 3(B) of Memorandum Explanatory to the Manipur Services (Revised Pay) (2nd Amendment) Rules, 2006 issued vide Office Memorandum No.1/12/2006-FD(PIC)(Pt), dated 23/05/2007.
