1. an election is to be held of a member to the Manipur Legislative Assembly in 36-Wabagai Assembly Constituency.

4. the nomination paper will be taken up for scrutiny at 11 a.m. on 12<sup>th</sup> January, 2012 (Thursday) at the office of the Returning Officer, Kakching at Mini Secretariat Thoubal D.C. Office's complex;
5. notice of withdrawal of candidature may be delivered either by a candidate or his proposer or his election agent (who has been authorized in writing by the candidate to deliver it) to either of the officers specified in paragraph (2) above at his office at Mini Secretariat Thoubal D.C office complex before 3 p.m. on the 14<sup>th</sup> January, 2012 (Saturday).
6. in the event of the election being contested, the poll will be taken on the 28<sup>th</sup> January, 2012 ( Saturday ) between the hours of 7 a.m. and 3p.m.
