Notice of withdrawal of candidature may be delivered either by a candidate or his proposer or his election agent (who has been authorized in writing by the candidate to delivered it) to either of the Officers Specified in Para (2) above at his/her office before **3:00 P:M on 14<sup>th</sup> January, 2012 (Saturday)**.
6. in the event of the Election being contested, the Poll will be taken on the **28<sup>th</sup> January, 2012 (Saturday)** between the hours of **7:00 A:M and 3:00 P:M**.
