Noren Singh, ARO for 56/Thanlon (ST) A/C, Shri. Kajaigai Gangmei, ARO for 57/Henglep (ST) A/C, Km. Laltanpuui Vanchhong, ARO for 58/Churachandpur (ST) A/C and 59/Saikot (ST) A/C and Smt. Rachel N. Guite, ARO for 60/Singngat (ST) A/C at the Office of RO, DC Office, Churachandpur between 11:00 am and 3:00 pm on any day (other than public holiday) not later than 11/01/2012 (Wednesday);
- (3) Forms of nomination papers may be obtained at the place and time aforesaid;
- (4) The nomination papers will be taken up for scrutiny at 11:00 am on 12/01/2012 (Thursday) at the Office of the Returning Officer;
- (5) Notice of withdrawal of Candidature may be delivered either by a candidate or by any of his proposers or by his election agent who has been authorised in writing by the candidate to deliver it to either of the officers specified in paragraph (2) above at his/her office before 3:00 pm on the 14/01/2012 (Saturday);
- (6) In the event of the election being contested, the poll will be taken on 28/01/2012 (Saturday) between the hours of 7:00 am and 3:00 pm.
