ALLOTMENT ORDERS  
Imphal, the 24th June, 2012

No. DC(IW)/8/18/Rev/05.— In pursuance of Government of Manipur, Secretariat Revenue Department letter No. 21/150/2005-R dated 3rd August, 2011, the undermentioned 36 (thirty six) persons are hereby allotted the following lands shown in the Schedule below for residential purposes under Section 14(1) of the MLR & LR Act, 1960 read Rule 18 of the MLR & LR (Allotment of Land) Rules, 1962.

- (2) The allotment is made subject to the conditions as laid down in Rule 15 of the MLR & LR (Allotment of land) Rules, 1962.
- (3) The allottee shall pay premium @ Rs. 36.26 per sq. ft. only as approved by the Govt. vide letter No. 21/150/2005-R dated 7th June, 2012. The premium shall be credited to Major Head-0029-Land Revenue on behalf of the Deputy Commissioner, Imphal West, Manipur within 3(three) months from the date of receipt of this order. One copy each of the Challan shall be furnished to the Undersigned and SDO/Wangoi.
- (4) The allottee shall pay land revenue as assessed under the MLR & LR Act, 1960 and relevant rules framed thereunder.
- (5) The land shall be liable to be resumed by the Govt. if it is not used for the purpose for which it has been allotted or if the allottee commits a breach of any of the conditions of allotment or provisions of the aforesaid rules within two years from the date of allotment.
- (6) The allottee shall execute a “Deed of allotment” on payment of the aforesaid premium amount.
- (7) Delivery of possession of the land shall be made by the SDO/Wangoi on receipt of the Challan copy for depositing the premium and on execution of the said “Deed of allotment”.
