Subject: Exit Examination for D.Pharm . Course under " Diploma in Pharmacy Exit Exam Regulations, 2022 "-reg.

The Pharmacy Council of India which is the apex body entrusted with the mandate to regulate the practice and profession of Pharmacy in the country has issued the under-reference circular with the following directions to all State Pharmacy Councils / Registration Tribunals:

"It is informed that Pharmacy Council of India (PCI) is going to conduct the Diploma in Pharmacy Exit Examination in July – September 2024 for 2022 – 24 academic sessions for D. Pharm. Course through NBEMS. The exact dates for Exit Examination will be announced in due course of time. In view of above, it is requested not to register the candidates as a registered pharmacists who have admitted in the 2022 – 23 academic session Diploma in Pharmacy and passed out in 2023 -24 academic session until they –

- i. Qualify the Exit Examination and
- ii. Fulfill the other prescribed conditions u/s 32 (2) of the Pharmacy Act, 1948".

The matter is being circulated in the interest of stake - holders for necessary adherence and general information.

No. 3/1/2024-CON : In exercise of the powers conferred by clause (2) and (3) of the Article 166 of the Constitution of India, the Governor of Manipur is pleased to make the following Rules further to amend the Business of the Government of Manipur (Allocation) Rules, 2009 namely :-

The Business of the Government of Manipur (Allocation)(19th Amendment) Rules, 2024

1. Short title and commencement :- (i) These Rules may be called the Business of the Government of Manipur, (Allocation)(19th Amendment) Rules, 2009.

(ii) They shall come into force with immediate effect.

2. Amendment Schedule Head No. 7 and Schedule Head No 14:-
 - i) Modification to existing entry no (xxii)(h) under **Schedule No. 7 – Textiles, Commerce and Industries Department** as :

“The Mines and Minerals (Regulation & Development) Act, 1957” **(excluding transit of Minor Minerals both from forest and non-forest area/patta land.)**

ii) Insertion of new entry (xv) under **Schedule No. 14 – Forest, Environment and Climate Change Department** as:

“Transit of Minor Minerals both from forest and non-forest area/patta land”.
