OFFICE MEMORANDUM

Imphal, the 4th June, 2024

No. 33/4/2022-HD-HD: Whereas, it has been observed that instances of granting bail by concerned competent Courts have increased manifold for reasons of expiry of statutory period and on grounds of lack of medical testing facilities like Ultrasound, etc in Jail especially in NDPS related cases;

2. Whereas, the State Government feels the necessity to bring improvement in the present Criminal Jurisprudence system especially the co-ordination between the State Government, Prosecutors and Police which was brought out in a review meeting held under the chairmanship of Ld. Advocate General, Manipur on 16-05-2024 ;

3. In accordance with the decisions taken in the review meeting and the earlier advisories issued related to the cases of preventive detention under PIT (NDPS) Act, 1988 vide Home Department letter No. H-33/4/2022-HD-HD dated 15-03-2023, the State Government decided to issue the following directives/ instructions for strict compliance by the Authorities concerned:

- i. The Director General of Police(DGP) shall direct the district Superintendents of Police and Superintendent of Police Narcotics & Border Affairs (NAB) to attach two Asst. Sub Inspectors to the office of Public Prosecutors.
- ii. The district Superintendents of Police shall expedite filing of chargesheets in NDPS cases, where statutory bail has been already granted.
- iii. The district Superintendents of Police shall expedite filing of chargesheet in cases where the statutory period is likely to lapse within the next 30 (thirty) days. If there is likelihood of not being able to file chargesheet before the expiry of statutory period, then in such case, extension for time shall be mandatorily sought from the Court.
- iv. All the NDPS cases will be compiled by Superintendents of Police of districts and NAB on priority basis and monitored regularly through the Addl./ Deputy Superintendent of Police designated for this purpose. Further, the Superintendents of Police concerned shall issue necessary advisories/ directives/ orders/ SOPs for dealing with NDPS cases within the district.
- v. The Investigating Officers, Officer in Charge of the Police station and shall be held responsible in cases of failure to file chargesheet in time or failure to file for time extension before the Court, explaining the inability to file chargesheet in time.
- vi. If the Medical Officer (MO) of Manipur Central Jail is of the view that a certain treatment or diagnosis required for the accused or the convict is not available in the Prison, then in such case, the MO shall inform the Superintendent of the Jail immediately who shall write to the Director of Health and

Commissioner (Home), requesting for the feasibility of such facility like Mobile Health Centre etc., in Jail itself. No report shall be submitted by the MO to the Ld. Court of Law without exhausting the above options.

- vii. In case of the proposals for preventive detention under PIT(NDPS) Act, 1988, the sponsoring Authority, district Superintendents of Police and Superintendent of Police Narcotics & Border Affairs (NAB) Investigating Officers, etc and all concerned Authorities shall comply with the advisories/ Instructions issued vide Home Department letter No. H-33/4/2022-HD-HD dated 15-03-2023 without fail.
4. These issues with the approval of the Competent Authority.
