Rules of Business of the Government of Manipur, (Amendment) 2025

- 1. Short title & commencement:
 - i. These rules may be called the Rules of Business of the Government of Manipur, (Amendment) 2025.
 - ii. It shall be deemed to have come into force with immediate effect.
- Amendment of Schedule Head: In the Schedule to the Rules of Business of the Government of Manipur, 2025, entry no. (xvi) "All Matters Relating to Manipur Staff Selection Commission" shall be inserted under Schedule Head No. 25. Personnel and Administrative Reforms Department.

NOTIFICATION Imphal, the 16th July, 2025

No. RWS-601/3/2020-T(MV)-TPT-Part (1): In line with the Government's commitment towards promoting digital transactions and financial transparency, and as part of the ongoing efforts to enhance delivery in public services, it has been decided to roll out Point of Sale (POS) terminals and other online payment systems for the collection of all applicable fees, taxes, charges and other services rendered by the Department of Transport, Government of Manipur w.e.f. 18th July, 2025. The primary objective of this initiative is to facilitate hassle-free, cashless payments for services such as license fees, vehicle registration, permit fees, penalties, and other user charges. The POS machines will accept debit/credit cards, UPI, and other digital payment methods. This initiative is expected to improve transparency, reduce cash handling, and enhance citizen convenience in line with the Digital India Programme with a vision to transform India into a digitally empowered society.

- 2. Further, cash transactions for all services rendered by the Transport Department, Government of Manipur shall be **discontinued w.e.f.18th July, 2025**. In exceptional cases, where the payment can not be carried out through POS then such transactions shall be carried through **Demand Draft** only after obtaining prior approval from the Director (Transport), Government of Manipur.
- 3. All District Transport Officers and Cashier of the Directorate of Transport are hereby directed to ensure the seamless rollout and compliance with these instructions. Any issues or feedback related to the use of POS machines should be reported to the Director Transport Manipur within one week of deployment.
