**No. 241 Q-Coop/Case/W.P.(C) No. 268 of 2024:** Whereas, the Registrar of Societies, Manipur, had cancelled the registration of "Radha Krishna Mandir, Prabandhak Karya Karni Committee", Regd. No. 11 of 1960-61 vide Order No. 11/SR/M/1960-61, dated 5<sup>th</sup> May 1999.

2. Whereas, the Registrar of Societies, Manipur, had revoked the Office Order No. 11/SR/M/1960-61, dated 5<sup>th</sup> May, 1999 cancelling the registration of "Radha Krishna Mandir, Prabandhak Karya Karni Committee", Regd. No. 11 of 1960-61, vide Order No. 11/SR/M/1960-61, dated 26<sup>th</sup> November, 2005.

3. Whereas, the Registrar of Societies, Manipur, had revoked the Office Order No.11/SR/M/1960-61, dated 26<sup>th</sup> November, 2005 vide Order No. 36 Q-Coop/Case/W.P.(C) No. 649 of 2006, dated 8<sup>th</sup> August, 2022, in pursuance of Judgement and Order dated 25/07/2019 passed by the Hon'ble High Court of Manipur in W.P.(C) No. 649 of 2006.

4. Whereas, the Registrar of Societies, Manipur, had appointed Shri Tonjam Ratankumar Singh, ARCS as Liquidator vide Order No. 36 Q-Coop/Case/W.P.(C) No. 649 of 2006, dated 8<sup>th</sup> August, 2022, in pursuance of Judgment and Order dated 25/07/2019 passed by the Hon'ble High of Manipur in W.P.(C) No. 649 of 2006.



5. Whereas, Shri Tonjam Ratankumar Singh, Liquidator had retired from his service on 28/02/2023.

6. Whereas, the Registrar of Societies, Manipur vide Order No. 36 Q-Coop/Case/W.P.(C) No. 649 of 2006, dated 4<sup>th</sup> March, 2024 appointed Shri T. Somokanta Singh, Deputy Registrar of Societies, Imphal East, as Liquidator and Shri Yengkhom Mohenjit Singh, Sub-Registrar of Societies, to assist the Liquidator.

7. Whereas, Shri T. Somokanta Singh, Liquidator had retired from his service on 31/12/2024.

8. Now, therefore, under Rule No. 32(2)(iv) of the Manipur Societies Registration Rules, 2004, I, Shri W. Ibohal Singh, the Registrar of Societies, Manipur, do hereby appoint Shri Kh. Tarunkumar Singh, District Cooperative Officer, Imphal West as Liquidator with immediate effect for winding up of "Radha Krishna Mandir, Prabandhak Karya Karni Committee", Regd. No. 11 of 1960-61, as per provisions of the Manipur Societies Registration Act, 1989 and its Rules 2004, and Shri Yengkhom Mohenjit Singh, Sub-Registrar of Cooperative Societies, Manipur to assist the Liquidator during the whole process of Liquidation, in addition to their normal duties. Further, the Liquidator shall ensure compliance of provisions of the Manipur Societies Registration Act, 1989 and its Rules 2004, and shall submit monthly progress report of the liquidation process of the Society on or before 5<sup>th</sup> of every month without fail.
