No. DC(IW)/8/39/Rev/2022 : In pursuance of Govt. of Manipur, Secretariat Revenue Department Order No. 21/15/2016-R dated 24th December, 2021 in favour of Ningthoujam Mohen Singh S/o (L) Yaima Singh of Leimaram for residential purpose has deposited an amount of Rs. 4,92,803/- (Rupees four lakh ninety two thousand eight hundred and three only) @ Rs. 164.10 per sq. ft. as approved by the Govt. vide letter No. 101/142/2022-REV-REVENUE dated 14th December, 2022 as premium of the land measuring 0.0279 hectare covered by C.S. 3. Further, concerned District Magistrate may co-opt a member of the transgender community if feels necessary.

Imphal, the 25th March, 2023

No. P-Coop/68/89 (Pt-VII): Whereas, Chairman and other Board of Directors of Manipur Milk Producer's Cooperative Union (MMPCU) was served Notice vide No. P-Coop/68/89 (Pt-VII), dated 10/03/2023 to give explanation on 24/03/2023 at 11.00 am for hearing as to why the Board of Directors should not be removed under Section 78(1) of Manipur Cooperative Societies Act, 1976 (Fifth Amendment).

Whereas, the Chairman, Manipur Milk Producer's Cooperative Union submitted a letter on 23/03/2023 with request to grant another 20 (twenty) days for giving written explanation.

Whereas, sufficient time was given to the Chairman and Board of Directors as per the provision of MCS Act, 1976, and accordingly, their request was not considered.

Whereas, Chairman and 6 (six) Board of Directors were present in the hearing held on 24/03/2023 at 11.00 am before the Registrar of Cooperative Societies.

Whereas, Chairman, MMPCU submitted a written explanation to the Registrar of Cooperative Societies, Manipur.

Whereas, in the written explanation, it is expressed that the Society has been implementing NPDD project under Ministry of Fishery, Animal Husbandry and Dairying, Government of India with project cost of Rs. 1999.89 lakhs during 2020-21 to 2022-23. Out of the above project cost, Rs. 1410.91 lakhs was released to the Union in two installments, and Utilization Certificate (UC) of Rs. 509.02 lakhs has been submitted. Out of Rs. 901.84 lakhs, it is reported that UC for Rs. 443.99 lakhs has been submitted to Department of Veterinary and Animal Husbandry, and UC for Rs. 457.85 is pending till date.

Due to non submission of pending UC, an amount of Rs. 444.00 lakhs has not been claimed, which has delayed the implementation of the project.

Whereas, Shri Dr. P. Krishnamohon Singh was nominated as Managing Director vide Order No. ADMV-101/3//2022-Vety, dated 12/10/2022 issued by Department of Veterinary and Animal Husbandry, and the said nomination was not placed before the Board by convening a Board Meeting for decision.

Whereas, some Board members accepted the nomination and some other Board members did not accept the nomination of Shri Dr. P. Krishnamohon Singh as Managing Director. Nomination of Dr. P. Krishnamohon Singh as Managing Director, was accepted by the Board of Directors only on 16/01/2023, after a long gap of 3 (three) months during which period the functioning of the Society was unduly hampered.

Whereas, the Chairman himself had directed the nominated Managing Director not to convene any Board meeting of the Society.

The action of the Board of Directors has caused delay in implementation of the Project. Further, no regular Board meeting was convened for a long time due to the action of the Board of Directors as a result of which the functioning of the society had come to a stalemate. Accordingly, the Board of Directors defaulted in performance of duties persistently for a long period causing delay in implementation of development programme

In view of the above, the Board is found violative of provisions of Manipur Cooperative Societies Act, 1976 and Rules, 1977.

Now, therefore, I Smt. Arambam Valentina, Registrar of Cooperative Societies, do hereby remove the Board of Directors of Manipur Producer's Cooperative Union, under the powers conferred upon me under Section 78(1) of Manipur Cooperative Societies Act, 1976 (Fifth Amendment) with immediate effect.
