#### OFFICE MEMORANDUM

Imphal, the 30th March, 2025

No.RWS-503/2/2024-T(MV)-TPT: Registration of Motor Vehicle under the Motor Vehicle Act, 1988 is mandatory. Section 39 of the Motor Vehicle Act, 1988 specify that no person shall drive any motor vehicle and no owner of the motor vehicle shall permit/ allow the vehicle to be driven in any public place unless the vehicle is registered and the registration mark/plate is displayed in the vehicle as prescribed in the Act.

- 2. Under the provision given in Section 40 of the MV Act, the motor vehicle shall be registered by the Registering Authority in whose jurisdiction the vehicle owner has residence or place of business where the vehicle is normally kept.
- 3. The Vahan portal has the provision for the Authorised Dealers to select the correct Registering Authority under whose jurisdiction the vehicle is to be registered. The Registering Authorities (District Transport Officer) have to check the documents submitted for registration. In case of improper selection of the Registering Authority by the dealer(s), the application should be returned back to the dealer.
- 4. The Registering Authority/District Transport Officers should comply with the Notification issued by the Director (Transport) vide Notification No. M-TPT/88/2024-DoPTT-DT dated 17<sup>th</sup> February, 2025.
