No.AS-101/11/2024-EDN(S)-EDN(S): Under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009 and under the Manipur Private School (Registration & Regulation) Rules, 2024, the Governor of Manipur is pleased to grant **provisional recognition** upto Class VIII in respect of **BBR Unique SCHOOL**, Thinungei, Bishnupur, Manipur and for affiliation to the Board of Secondary Education, Manipur from the Academic Session, 2024-2025 subject to the condition that the School shall abide by the provision of Right to Free and Compulsory Education Act, 2009, the Right of Children to Free and Compulsory Education Rules, 2010 and the Manipur Private School (Registration & Regulation) Rules, 2024.

Further, the School shall ensure that the provisional recognition be renewed on expiry of 2 (two) years from the date of issue of the order.

No. PLCY-302/2/2020-Cabinet (Part-1): In exercise of the powers conferred by clause (3) of Article 166 of the Constitution of India and in pursuance of decision of the Cabinet taken during its sitting on 30.08.2024, the Governor of Manipur is pleased to amend the Business of the Government of Manipur (Allocation) Rules, 2009, namely: -

The Business of the Government of Manipur (Allocation) (20th Amendment) Rules, 2024.

1. Short title & commencement:

- i. These rules may be called the Business of the Government of Manipur (Allocation) (20th Amendment) Rules, 2024.
- ii. It shall be deemed to have come into force with immediate effect.

2. Amendment of Schedule Head 34: In the Business of the Government of Manipur (Allocation) Rules, 2009 under Schedule 34 - Social welfare Department, the following new entry shall be inserted after entry 13 under sub-heading - (A) Social Welfare Division:

"14. All matters relating to handling, prevention, prohibition, restriction of begging in all forms prevalent in the State".
