### REVISED GUIDELINES FOR GRANT-IN-AID FOR ORGANIZING STATE LEVEL GAAN-NGAI CELEBRATION

continuation No.TA-701/19/2024-e-TA & H:of In this Department Guidelines for Grants-in-Aid for organizing State Level Gaan-Ngai Celebration No. 7/24/2015-TAH & SC (HC) 12<sup>th</sup> October 2021, the followings shall be inserted/replaced/deleted:

- 1. The words appearing in the Para No. 1 of the Guideline viz; "The Gaan-Ngai is the biggest and most colorful festival of the Kabui/Rongmei people who follow the Kabui indigenous Religion (Tingkao Ragwang Chapriak)" shall be read as, "the Gaan-Ngai festival is the biggest and most colorful festival of the Kabui/Rongmei community".
- 2. The last sentence of Para No. 1 viz; "Thus Gaan-Ngai is a ritualistic festival of the Kabui/Rongmei people professing the Kabui/Rongmei indigenous Religions" is deleted.
- 3. The words appearing in Para No. 3 Sub-Para (i) viz; "The Association or group of persons must be a registered Association registered under the Manipur Societies Registration Act, 1989 at the state level and having promotion of Kabui/Rongmei indigenous Religion in general and celebration of Gaan-Ngai in proper spirit, in particular as one of its objectives" shall be read as "The Association must be a registered Association registered under the Manipur Societies Registration Act, 1989 or any Association or group of persons having promotion of Kabui/Rongmei community in general and celebration of Gaan-Ngai in proper spirit, in particular as one of its objectives".
- 4. The words appearing in Para No. 3 Sub-Para (ii) viz "The Society/Associations shall compose of Members only from Kabui/Rongmei Community who practices and professes the Kabui/Rongmei indigenous Religion" shall be read as, "The Society/Associations/group of persons shall compose of Members from Kabui/Rongmei Community."
- 5 The words appearing at Para No. 3 Sub-Para (iii) viz "The society shall have at least 3 (three) years standing since the registration till the application" is deleted.
  - 6. The words appearing at Para No. 4 viz "Every Association desirous of availment of the Grant-in-Aid must keep in mind that the Grant—in-Aid shall be given to only one Association among all the Applicants" shall be read as "Every Association/Society/Group of persons desirous of availment of the Grant-in-Aid must keep in mind that the Grant—in-Aid shall be given to only one Association/Society/Group of persons among all the Applicants"

- 7. The words appearing at Para No. 5 viz "Every registered Association of group of persons shall contain in their Memorandum of association the following aims and objectives" shall be read as "Every Association/Group of Persons/Society desirous of availing the Grant-in-Aid shall have the following Aims and Objectives"
- 8. Para No. 6 of the Guideline viz "Every application made for availment of Grants-in-Aid must be made and signed either by the President or the Secretary of the society declaring that the application is made bonafide and that there is no political or ulterior motive in making the same" is deleted.
- 9. The words appearing at Para No. 7 viz "The Grant-in-Aid for State level Gaan-Ngai celebration shall be awarded to the fit Association fulfilling the above Criteria after verification by screening Committee consisting of" shall be read as "The Grant-in-Aid for State Level Gaan-Ngai celebration shall be awarded to the fit Association/Society/Group of persons constituted for organizing the State Level Gaan-Ngai festival fulfilling the above criteria after verification by the Screening Committee consisting of".
