No. PIC-18/56/2025-e-FD: Proposals for contractual engagement or extension of contractual engagement of any officer/official/staff are submitted to the Finance Department (Pay Implementation Cell) for placing before the Committee of Officers (CoO), and thereafter, for obtaining views/comments prior to submission of the proposals to the Governor-in-Council (GIC). In order to facilitate timely examination and processing of such proposals, concerned Administrative Departments are hereby advised to submit the proposal to the Finance Department (Pay Implementation Cell) at least three (3) months prior to the proposed date of commencement of the contractual engagement or extension of contractual engagement.

2. This instruction shall take effect from the date of issuance of this Office Memorandum and shall not apply to proposals already submitted to the Finance Department (Pay Implementation Cell) before this date.
