No.8/177/2019-For & Envnt: In exercise of the powers conferred under Section 26, 32, 51 and 76 of the Indian Forest Act, 1927, the Governor of Manipur is pleased to make the following amendments of the Manipur Forest Rules, 1971 with immediate effect until further orders:

Rule 27- <u>Levy of Royalty</u> : The Chief Conservator of Forest shall levy rates of royalty payable for each kind of forest produce removed from protected forest according to schedule fixed by the Government from time to time.
