In exercise of the power conferred by clauses (1) & (2) of Article 229 of the Constitution of India, Hon'ble The Chief Justice of the High Court of Manipur is pleased to make the following rules so as to amend the High Court of Manipur IT Cadre Service (Appointment & Conditions of Service) Rules, 2018: -

**THE HIGH COURT OF MANIPUR IT CADRE SERVICE
[APPOINTMENT & CONDITIONS OF SERVICE (AMENDMENT)] RULES,
2021.**

1. Short title and commencement: -

- (i) These rules shall be called the High Court of Manipur IT Cadre Service [Appointment & Conditions of Service (Amendment)] Rules, 2021.
- (ii) They shall come into effect from the date of their publication in the Official Gazette of Manipur.

2. The existing Sub-Rule (iii) of Rule 5 of the High Court of Manipur IT Cadre Service (Appointment & Conditions of Service) Rules, 2018, shall be substituted by the following: -

‘**Sub-Rule (iii) (A):** The existing Senior Technical Officer, 2 (two) Developers & 2 (two) Technical Assistants, recruited on contractual basis to assist in the office of the Central Project Coordinator (CPC), as per the guidelines laid down in the Minutes of the Meeting of the eCommittee, Supreme Court of India, held on 4th February, 2016, under Phase-II, eCourts, Mission Mode Project, shall be absorbed as System Officers.’

‘**Sub-Rule (iii) (B):** For the purpose of such absorption, the said Senior Technical Officer, Developers & Technical Assistants shall be treated as System Officers, as defined in Category No.3 of Rule 5 (1) (i) of the High Court of Manipur IT Cadre Service (Appointment & Conditions of Service) Rules, 2018.’

‘**Sub-Rule (iii) (C):** Determination of *inter se* seniority of the System Officers absorbed as per Sub-Rule (iii) (A) of Rule 5, inserted by these amended rules, shall be based on who drew the higher salary in the previous posts and in case of candidates holding the same post with the same salary, their seniority shall be determined according to their merit in the selection list prepared at the time of their recruitment. Further, if the marks scored are also the same, then the candidate who is older shall be treated as the senior.’
