**NOTIFICATION**

Imphal, the 1<sup>st</sup> April, 2010

**No. 3/15/90-MFS/DP(Pt):** In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Manipur is pleased to make the following rules further to amend the Manipur Forest Service Rules, 1986, namely :-

**1. SHORT TITLE AND COMMENCEMENT :-**

- (i) These Rules may be called the Manipur Forest Services (Amendment) Rules, 2010.
- (ii) These Rules shall come into force with effect from the date of publication in the official Gazette of Manipur.

**2. In Rules 5 of the Rules the following shall be substituted :-**

- (i) Save as provided in rule 26, appointment of the service after commencement of these rules shall be made by the following methods:-
  - (A) Appointment to Grade-I/Selection Grade of the Service shall be made by promotion in the manner specified in part-IV of these rules.
  - (B) 50 percent of the authorized permanent strength of the service shall be filled by direct recruitment in the manner specified in part-V of these rules.
  - (C) 50 percent of the authorized permanent strength of the service shall be filled by promotion as below:

Range Forest Officers with diploma in Forestry/Wild Life from any State Forest Service College/Wild Life Institute of India recognized by the Govt. of India, Ministry of Environment & Forests who have put in 4(four) years regular service in the grade of Range Forest Officer including those periods spent on training on the Diploma course.

**Failing which**

Range Forest Officers with Certificate in forestry/Wild Life from any State Forest Service College/Wild Life Institute of India recognized by the Govt. of India, Ministry of Environment & Forests who have put in 5(five) years regular service in the grade of Range Forest Officer including those periods spent on training on the Certificate course.

**Failing which**

Range Forest Officers without Diploma/Certificate in Forestry/Wild Life who have put in 7 (seven) years regular service in the grade of Range Forest Officer.

3. For the existing Scheduled-I, the following shall be substituted.
